

## END USER SOFTWARE LICENSE AND MAINTENANCE AGREEMENT (CODEANT, VERSION 2023.5)

### **1. SCOPE AND KEY TERMS.**

The Licensed Product is the proprietary information of ValiantSec or its suppliers who retain exclusive title to their intellectual property rights in the Licensed Product. Customer's rights to the Licensed Product are limited to those expressly granted below and ValiantSec reserves all rights not expressly granted in this Agreement.

#### **1.1 Developer**

"Developer" means the author of CodeAnt: ValiantSec, Changsha, China.

#### **1.2 JetBrains**

"JetBrains" means JetBrains s.r.o. with its registered office at Na Hřebenech II 1718/10, Prague, 14000, Czech Republic, registered with the Commercial Register kept by the Municipal Court of Prague, Section C, file 86211, ID.Nr.: 265 02 275.

#### **1.3 JetBrains Affiliate**

"JetBrains Affiliate" means the subsidiary and/or any associated companies of JetBrains.

#### **1.4 JetBrains Marketplace**

"JetBrains Marketplace" means any platform operated by JetBrains or a JetBrains Affiliate on which JetBrains or a JetBrains Affiliate markets Plugins for JetBrains Products, including the website <https://plugins.jetbrains.com> and/or any other website or other platform, whether named JetBrains Marketplace, JetBrains Plugins Repository, or otherwise.

#### **1.5 JetBrains Product**

"JetBrains Product" means any software program or service made available by JetBrains.

#### **1.6 Plugin**

"Plugin" means the Plugin for JetBrains Product that Developer makes available under this EULA.

#### **1.7 Licensed Product**

"Licensed Product" means the specific products (including hosted products designated as "Subscription Services" in the Purchasing Agreement) provided by ValiantSec and listed in a Purchasing Agreement and (a) all related Documentation, and (b) all updates (including Licensed Product Updates), modifications and maintenance services provided to Customer.

#### **1.8 Plugin Information**

"Plugin Information" means the following information and materials: (a) JetBrains Marketplace Plugin title, tags / category, name(s) of Developer(s), product description, icon, logo or banner images, and any other information related to Plugins; (b) the metadata, graphics, artwork, images, trademarks, trade names, logos and other descriptive or identifying information and materials associated with Developer or appears in connection with Plugin; and (c) in the case of cloud hosted Plugins, an XML/JSON descriptor of Plugin.

#### **1.9 Plugin Users**

"Plugin Users" means users that are able to access and use Plugin concurrently.

#### **1.10 You/Authorized User/Customer**

"You/Authorized User/Customer" means an individual or an entity concluding this EULA.

### **2. LICENSE**

2.1 This EULA governs the terms of use of Plugin made available to You via JetBrains Marketplace. This EULA is entered into between You and Developer.

## **2.2 License Grant**

Subject to Customer's compliance with this Agreement, ValiantSec grants Customer a nonexclusive, non-transferable license, solely during the license term and in the Territory set out in the applicable Purchasing Agreement, to use and operate the Licensed Product to the extent permitted by Customer's payment of applicable fees, solely for the purpose of developing, analyzing, building or testing the Code Base, or other license constraint identified in such Purchasing Agreement.

## **2.3 Conditions**

The rights granted to Customer above are conditional upon Customer's compliance with the following obligations:

2.3.1 Customer will not copy ValiantSec's Licensed Products or Documentation, in whole or in part, except as expressly authorized in this Agreement.

2.3.2 Customer will not transfer, assign, lease, lend or rent ValiantSec' Licensed Products or Documentation, use them to provide service bureau, time-sharing or other services, or otherwise provide or make the functionality thereof available to third parties except as expressly authorized in this Agreement.

2.3.3 Customer will not disassemble, decompile, reverse engineer, modify or create derivative works of the Licensed Products or Documentation nor permit any third party to do so, except to the extent such restrictions are prohibited by applicable mandatory local law.

2.3.4 Customer will not allow access or use of the Licensed Products by, and will not display the Licensed Products user interfaces to anyone other than the Authorized Users without ValiantSec's prior written consent.

2.3.5 Customer will not disclose to any third party any comparison of the results of operation of the Licensed Products with other products.

2.3.6 Customer will not delete or in any manner alter the copyright, trademark or other proprietary rights notices appearing on the Licensed Product as delivered by ValiantSec. Customer will reproduce such notices on all copies Customer is authorized to make of the Licensed Product.

## **3.PLUGIN**

3.1 You are authorized to use Plugin in accordance with its documentation provided by Developer and for the period of time specified by Developer.

3.2 If Plugin is a paid Plugin, you must ensure that the maximum number of Plugin Users does not exceed the number of Plugin Users for which you have purchased Plugin.

3.3 Plugin is protected by copyright and other intellectual property laws and treaties. Developer or its licensors own all title, copyright and other intellectual property rights in Plugin.

3.4 ALL PLUGINS ARE PROVIDED TO YOU ON AN "AS IS" AND "AS AVAILABLE" BASIS WITHOUT WARRANTIES. USE OF PLUGINS IS AT YOUR OWN RISK. DEVELOPER MAKES NO WARRANTY AS TO PLUGIN' S USE OR PERFORMANCE. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, DEVELOPER DISCLAIMS ALL OTHER WARRANTIES AND CONDITIONS, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT, WITH REGARD TO PLUGINS, AND THE PROVISION OF OR FAILURE TO PROVIDE SUPPORT SERVICES. DEVELOPER DOES NOT WARRANT THAT PLUGINS ARE ACCURATE, RELIABLE, OR CORRECT; THAT PLUGIN MEETS YOUR

REQUIREMENTS; THAT PLUGINS WILL BE AVAILABLE AT ANY PARTICULAR TIME OR LOCATION, UNINTERRUPTED, OR SECURE; THAT ANY DEFECTS OR ERRORS WILL BE CORRECTED; OR THAT PLUGINS ARE FREE OF VIRUSES OR OTHER HARMFUL COMPONENTS.

#### **4. TERMINATION**

4.1 This EULA agreement is effective from the date you first use the Plugin and shall continue until terminated. You may terminate it at any time upon written notice to CodeAnt.

4.2 It will also terminate immediately if you fail to comply with any term of this EULA agreement. Upon such termination, the licenses granted by this EULA agreement will immediately terminate, and you agree to stop all access and use of the Plugin. The provisions that by their nature continue and survive will survive any termination of this EULA agreement.

#### **5. DISCLAIMER**

ValiantSec does not warrant that the Licensed Product will meet Customer's requirements, that the Licensed Product will operate in combinations with equipment, devices, software or systems provided by persons other than ValiantSec, that the operation of the Licensed Product will be error-free or uninterrupted, or that the Licensed Product will discover all open source or third-party code, potential license conflicts, errors and vulnerabilities that may reside in the Code Base.

#### **6. OWNERSHIP OF IP RIGHTS**

ValiantSec and its licensors own all patent rights, copyrights, trade secret rights, mask works, and trademark rights (including service marks and trade names), and any applications for these rights, in all countries ("Intellectual Property Rights") in the Licensed Products and the Documentation. Customer's only rights in the Licensed Products and the Documentation are the rights expressly granted in this Agreement; all other rights are reserved by ValiantSec. ValiantSec's licensors are third-party beneficiaries of, and thus may enforce against Customer, the license restrictions and confidentiality obligations in this Agreement with respect to their intellectual property and proprietary information.

#### **7. GOVERNING LAW**

This EULA agreement, and any dispute arising out of or in connection with this EULA agreement, shall be governed by and construed in accordance with the laws of China.
